Introduction :

What is the difference between accreditation and certification ?

Certification

insurance, given by a third party, that a product, a service, or a system, is **conform** to specific requirements.

This insurance is formalized by a written document (certificate)









Introduction :

What is the difference between accreditation and certification ?

Accreditation

Recognition, given by a third party, of the **competency** of an organization in a dedicated field of activity.

Giving credit is giving confidence

- Give confidence in the work we do
- Increase the relationship with our customers
- Need for international recognition
- Facilitate the deal between countries









Introduction :

What is (are) the reason(s) why your lab should be accredited ?

- Enhance the general level of knowledge of the lab
- Bring an obvious bonus to a competitor
- Label an unknown activity
- It's the latest fashion
 - ex : in France 1 ENV Lab accredited in 1990 130 Labs in 2013









Introduction :

What is (are) the reason(s) why your lab should be accredited ?

- It protects the lab
 - ex : client's complaint when appearing in court
- It's the only way to keep working
- Should promote the motivation of the personnel through a team project of (re)organization and competency promotion

Non conformity weight :

- Impact on the final result
- o Do not match with major requirements

Major Non-conformity

- Do not match with minor requirements
- o Default of formalization

Minor Non-conformity

No impact on the organization, but
this tool is used by the assessor to ensure
the necessary change will be made.

Remark







Behaviour of the assessor (auditor) :

The assessor is an expert, and considered as a reference.

- □ He/she is the representative of an <u>official</u> organisation
- □ He/she must be **impartial.** Its judgment must target a <u>SYSTEM</u> and not
- □ He/she must be **fair**

the **<u>PEOPLE</u>**

- □ He/she must assess the **consistency** (coherence) of the system
 - ☐ He/she must not try to compare with its own requirements

Description of a non-conformity (NC) :

The NC is used to report to the accreditation body committee.

□ It must be **factual**

□ It must never be **nominative** or **comparative**

Lt must be clear

□ It must not contain any **opinion** or **advice**

□ It must be accurate

□ It must give detail of the **risk assessment** of the fact
